**RE:** CCPA on the Conservative hit list?

Dear Erin,

Thanks to your generous support, the Canadian Centre for Policy Alternatives is Canada's leading independent voice researching and promoting policies on economic, social and environmental issues.

Unfortunately, the vital research you make possible is in danger as the Conservative government ramps up their attacks against those who question or disagree with their policies. **And as an outspoken critic, I worry that the CCPA will be targeted for removal of our charitable status — an important tool for funding our research.**

The Harper government has demonstrated its disregard for policy-making based on sound research and evidence, but instead is making decisions based on narrow-minded ideological priorities — regardless of what's best for Canadians like you and me.

The Conservative government has taken unprecedented actions to silence alternative points of view and stifle the free flow of information that is vital to a modern democracy. These include:

- Major cuts to Statistics Canada and elimination of the compulsory long-form census — the most crucial policy tool available for analyzing poverty and inequality in Canada.
- Abolishment of the National Council of Welfare, a federal agency whose authoritative reports on issues like welfare incomes, child poverty, pensions and the justice system have been widely used both inside and outside of government for sound policy-making.
- Removal of funding of prominent arms-length social and labour market policy research institutes — forcing their closure.
- Drastic weakening of environmental assessment rules allowing easier approval of risky new projects like pipelines with little or no public input allowed.
- An aggressive campaign against non-profit organizations critical of the government, threatening to remove their charitable status and ability to issue tax receipts.
- Pushing through a massive Omnibus budget bill with far-reaching consequences while providing minimal time for Parliament to discuss or debate the issues.

These attacks have already had a chilling effect on those speaking out for a democratic and just society... they are silencing dissent.
